In signing this agreement, the owner(s) accept and acknowledge the following terms and conditions which pertain to the boat, motor and equipment described on this agreement. I/We, the sole Owner(s) of the boat agree that the marina is released from liability for damages or loss no matter how it occurs to the boat, motor and equipment while under the control and direction of the marina, and agree that the above property is insured by me/us against any loss or damage while on the premises of the Marina. The Marina shall have a lien against the boat, motor and equipment for unpaid sums due for use of the marina facilities, for repairs and supply and/or leasing of parts and accessories or for damage caused or contributed by the boat or by the owner(s) to any docks or property of the marina, or any other person on the marina premises. In addition to the liens provided for, the marina shall have liens under the Repair and Storage Liens Act 1989 (Ontario) or such other replacement or successor statutes.

It is expressly acknowledged that this Winter Storage Agreement shall create a license agreement between the Marina and the Owner(s), wherein the owners(s) is licensed to use the storage space and area, from time to time designated by the Marina, for the winter storage of the owner(s) boat. The owner(s) agrees that the marina does not assume any duty to care for the boat or to prevent loss or damage thereto except when the Marina performs work on the boat. **The deposit is non-refundable. However, Lakeview CAM reserves the right to cancel your reservation and refund your deposit in the event that space is not available.**
